Razionale

The WHO/UNECE Protocol on Water and Health to the 1992 Convention on the Protection and Use of Transboundary Watercourses and International Lakes was adopted in London, 17 June 1999, at the Third Ministerial Conference on Environment and Health. The Protocol is an international legally binding agreement for countries in the pan-European region, aimed to protect human health and well-being, both individual and collective, through sustainable water management and by preventing and controlling water-related diseases. The Protocol represents the instrument to be promoted for managing water as a single entity, encompassing environmental protection and aquatic ecosystems, improving water resource management and protection, and preventing, controlling, and reducing waterborne diseases.

The Ministry of Health has coordinated technical work for the presentation of the draft law for ratification of the Protocol (presented by the Ministry of Foreign Affairs and International Cooperation on November 10, 2023, approved by the Chamber of Deputies on October 14, 2025, and transmitted by the President of the Chamber of Deputies to the Presidency on October 16, 2025).

ISS, as Italian focal point, has contributed to the Protocol’s work, particularly in coordinating (together with the Kingdom of the Netherlands) the Programme area 7 of the Protocol, aimed to increase resilience to climate change.

In 2023, the applied research project entitled “*Water, Climate and Health: from environmental protection of resources to access to water, to safe use (ACeS)*” was launched. The project is part of the PNC – Mission 6, Sub-Investment 1.4: “*Promotion and funding of applied research with multidisciplinary approaches in specific Health–Environment–Climate intervention areas*” and is aimed to the ratification of the Protocol on Water and Health. As part of that project, it is organized this conference.



Aims

The conference will offer a platform for discussion with the Protocol's international scientific and coordination bodies. It will serve also as the first technical roundtable for stakeholders tasked with supporting the activities of the Permanent National Commission on Water and Health.

The event will focus on the range of water-related issues addressed by the WHO-UNECE Protocol on Water and Health, the targets to be met, and will establish the groundwork for strengthening institutional cooperation and enhancing networking.

Working method

Talks and roundtable. The event is structured into 7 sessions:

- Session 1 - 3 provide the overall framework on the Protocol on water and health, its obligations and the role of the WHO/UNECE secretariat in supporting implementation, point out Protocol Parties experience on local implementation, highlight roles, activities and initiatives of Italian national organizations related to the Protocol targets.
- Session 4 - 6 are focused on different types of water to which the Protocol applies. During each session, experts from both the health and environment sectors will share a perspective of law, project and activities ongoing, whose objectives and results could support the achievement of the objectives of the Protocol.
- Session 7 highlights the role of local authorities and the possible contribution of trade associations and the third sector to the implementation of the Protocol on water and health
