INFORMATION ON THE PROCESSING OF PERSONAL DATA of the users visiting the website of the Istituto Superiore di Sanità (Italian National Institute of Health) Pursuant to Article 13 of the EU Regulation 2016/679

WHAT IS THIS INFORMATION?

Visiting the website of the Istituto Superiore di Sanità (ISS) may result into processing data relating to identified or identifiable natural persons (personal data).

The information provided below describes the processing operations performed on the personal data of the users visiting ISS website (http://www.iss.it), as required by the EU Regulation 2016/679 (hereinafter, Regulation).

This information applies only to ISS website and does not concern any other sites, pages or online services accessible via hypertext links that may be published on the site but referring to external resources.

LEGAL BASIS FOR THE PROCESSING

The personal data mentioned on this page are processed by the Istituto Superiore di Sanità in discharging its tasks that serve the public interest or are related to the exercise of its institutional duties.

CATEGORIES OF PERSONAL DATA AND PURPOSES OF THE PROCESSING

a) Browsing data

The computer systems and software procedures in use to operate this website acquire, during their normal operation, some personal data, whose transmission is implicit in the use of Internet communication protocols. This information is not collected to be associated with identified subjects, but it could allow the identification of users, through processing and association with data held by third parties. This kind of data includes IP addresses or domain names of the

computers connecting to the site, the addresses in the Uniform Resource Identifier (URI) of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (success, error, etc.) and other parameters relating to the operating system and the computer environment of the user. These data are used with the only aim to provide anonymous statistical information on the use of the site and its correct functioning, and are deleted immediately after processing. Further, the data could be used to ascertain responsibilities in case of cyber crimes against the site.

b) Data communicated by users

Sending of messages to ISS contact addresses and filling in and sending the forms made available on ISS website on the basis of the user's voluntary, explicit choice, will entail the acquisition of the sender's contact information necessary to provide a reply, along with all the personal data communicated in that manner. Omission in providing such data could imply not obtaining what requested.

c) Cookies and other tracking devices

In compliance with the simplified procedures for the information and the acquisition of consent for the use of cookies - 8 May 2014 (Published in the Official Gazette No. 126 of 3 June 2014), and subsequent amendments and integrations, this site uses only *technical cookies*.

Cookies used, directly implemented by ISS, are:

- choice of the CSS by the user (in compliance with Law 4/2004 and subsequent amendments and integrations)
- acknowledgement of the information on the legislation concerning cookies
- possible SESSIONID for restricted access areas, managed with another product, different from the one serving the website

For the new ISS site, an Open Source Software, WordPress, is temporarily in use, not hosted by the manufacturer but by machines under the control of ISS; as for Automattic (which produces WordPress) policies, in general, visit https://it.wordpress.org/about/privacy/

ISS makes no use of any data collected by the product, nor sends this data to any party.

DATA SUBJECTS' RIGHTS
