Whereas

⇒ ISS and ECDC have signed on 02.04.2014 the specific contract No 2 - ECD 4766 to carry out the services within the framework contract ECDC/2013/014 "Framework on migrant health and infectious diseases" which form an integral part of this agreement;

⇒ The ASL is a partner of the specific contract mentioned above and therefore shall be jointly liable with ISS for the performance of the specific contract.

The ASL undertakes, in accordance to the ECDC specific contract No 2, to perform the following activities:  
- support to the following Deliverables:

- ✓ **DL5:** participation to the 5<sup>th</sup> European Conference on migrant health and ethnic minority health, taking place in Granada 10-12 April 2014
- ✓ **DL6:** 2<sup>nd</sup> draft framework and report on migration flows for ECDC and EU/EEA Member State review (to be delivered 1 October 2014)
- ✓ **DL7:** A final report on the framework on migrant health and infectious diseases (to be delivered 30 January 2015)
- ✓ **DL8:** A final report on migration flows to the EU/EEA and the potential impact on infectious disease transmission (to be delivered 30 January 2015)
- ✓ **DL9:** An EndNote library with all references from the final reports (to be delivered 30 January 2015)

- ✓ **DL10:** Two short briefs (four pages each) targeted to policy makers reporting the key findings from the framework and the report on migration flows (to be delivered 30 January 2015)
- ✓ **DL11:** A PowerPoint presentation showing the main findings from the two main outputs (to be delivered 30 January 2015)
- ✓ **DL12:** Two draft scientific articles with the main findings of the framework and the report on migration flows (to be delivered 30 January 2015)

For any other provisions, the ASL undertakes in accordance with the terms set out in the Framework Contract No ECDC/2013/014.


