

LETTER OF AGREEMENT

BETWEEN

ISTITUTO SUPERIORE DI SANITA' with office located in Rome, Italy, viale Regina Elena 299, 00161, V.A.T. number IT03657731000, fiscal code 80211730587, itself represented for the signature of this Agreement by Mrs. Rosa Maria Martoccia, Financial Officer (hereinafter referred as "ISS")

AND

TANZANIA VETERINARY LABORATORY AGENCY (TVLA) with office in **Dar es Salaam, Tanzania, at Veterinary complex, 131 Nelson Mandela Road**, V.A.T. number **118-861-965**, itself represented for the signature of this Agreement by **Mr Richard Masanja**, **Director of Business Development** (hereinafter referred as "TVLA")

RECITALS

WHEREAS the World organisation for Animal Health (OIE) has agreed to provide funds to ISS for the purpose of supporting the twinning project entitled "Trichinella infections in animals and foodstuff of Tanzania" between ISS and Tanzania Veterinary laboratory Agency (TVLA);

- WHEREAS the project will rely on the cooperation of "TVLA" (annex 1 of the twinning project)
- WHEREAS "TVLA" owns skills and resources suitable to the activity foreseen in the Project;
- WHEREAS the Parties intend to regulate inter se their relationship within the frame of the Grant Agreement,

IT IS AGREED as follows:

The preamble and Annexes here attached are considered as substantial part of the present Agreement.

Article 1. – Interpretation

- 1.1 The present Agreement is strictly related to the Grant Agreement.
- 1.3 "TVLA" declares to acknowledge and to accept all the obligations arising from the Grant Agreement.

Article 2. - Applicable law

2.1 This Agreement shall be governed by the law of the Republic of Italy. This agreement is draw in English and all documents shall be in English.

Article 3. – Duration of Agreement

3.1 This Agreement shall enter into force only after the last signature of the contracting parties for a two year period.

Article 4. - Activity

4.1 TVLA shall fulfil the activity of Workplan 2 and Workplan 3 (annex 2 of Twinning Project point 2.4).

Article 5.- Obligations

- 5.1 Under the terms of this agreement ISS entrusts TVLA, which accepts, to contribute to the achievement of the requirements of Specific LIFE-CONTRACT together with the contractor.
- 5.2 In particular, TVLA undertakes to perform with due diligence, the activity as provided in the annex 2 of the attached twinning project.

Article 6.- Money transfer

- 6.1 ISS will transfer to TVLA the following amount for the performance of the above activities:
 - € 6.000,00 as pre-financing after the signature of this subcontract, of which €3.000,00 for sample collection on the field; €1.000,00 for the shipment of samples from the field to TVLA; and €2.000,00 for consumables for the laboratory at TVLA;
 - € 7.500,00 for the organization of the final meeting within two months of the event, only if TVLA having made the forwarding of the original documents relating to the pre-financing (€ 6.000,00) (e.g., invoices, tickets, receipts).

TVTLA must reporting back all the expenditure actually incurred by attaching supporting documents and send them, in the original, to the ISS for the final report to the OIE. TVLA also must return any unspent funds to ISS by 31 October 2016.
